The purpose of this letter is to inform you that your Local Workforce Development Board (LWDB) will be receiving a monitoring review of its implementation of the Workforce Innovation and Opportunity Act (WIOA) for PY21.

Currently we are planning to be onsite to conduct our review but given the uncertain situation with the COVID-19 variant, we should prepare as if this review will be conducted remotely, similar to the PY20 review. The onsite review for Workforce Development Council of Seattle-King County is scheduled to begin on May 2, 2022. A remote desktop review will begin the week prior to the onsite review.
